#### 2.1.2. Analysis of the Problems

Hofstede's theory of power distance points out that "power inequality exists in all cultures, and the difference is people's acceptance and attitude towards it."In a culture of large distance from power, people believe that the existence of power inequality is a basic fact of society, and the high status people think that there is a gap between them and those with low status people, and it will strengthen this gap. At the beginning of his speech, Chinese classmate A stressed that the two people with different status basically could not understand and communicate with each other, highlighting the importance of status, and representing that China is a typical country with high power distance. Indeed, due to identity differences, social meetings were fixed in their own circle, forming a "circle culture". Whether they choose the future or enjoy the present, they remain optimistic that change will bring progress and development. There are three different orientations in the principle of value orientation: emphasizing the past, emphasizing the present, and emphasizing the future. American culture is typically futuristic, emphasizing change, and believing that the future will be better than now, and people who stick to tradition tend to be ridiculed. And for the future, they are more willing to experience and face the new challenges in their life. And China and other Asian countries are typical of the past time orientation of countries, we speak in many public places in "century-old schools, we have achieved ...in the past glorious achievements"," look back at the long history, predecessors ... They are " much more inclined to establish more rules and regulations, cannot tolerate unconventional thoughts and behavior, seek group consensus and identity, believe in absolute truth and expertise, and feel anxious and nervous about vague things."" The Chinese care more about whether they have the power to respond to messages, not about the consequences of uncertainty. "In this respect, China is more tolerant of unconventional people and things, emphasizing personal creativity, being willing to take risks, and being more flexible and casual. 5

At the same time, can not read back also reflects the conflict between high and low context in Chinese and American verbal communication."Hall's theory of high and low context culture refers to a matter of course idea when people socialize about how much listeners know what they are talking about. In low context communication, the listener knows very little about what is said and must be clearly informed of all things, while in high context communication, the listener already understands the context and does not need to provide background information."Here, as Wechat serves as a written language system, Americans' attention to the timeliness of message responses reflects the characteristics of being a high-context culture, while Chinese people try to refuse things, trying to maintain interpersonal harmony by maintaining silence, delayed responses and ambiguous words. Therefore, many Westerners from low-context countries often fail to understand the implicit and awkward expression of Chinese people, believing that they cannot lack responsibility, and Chinese people do not like the direct and frank problems of Westerners, and often believe that Westerners have "low EQ. 6

#### 3.2.3. Problem Solving
