2.3. Teaching content lags behind and lacks professional teaching materials

Many schools in drug prevention education, although issued the relevant teaching materials, but only as students' extracurricular books, no professional guidance and teaching, cannot guarantee the quality of drug prevention education, teenagers such "formalism" also confirmed the actual effect of many school drug prevention education work is satisfactory, more is a form than substance.

3. Advantages of "Internet + Drug Prevention Education"

Under the new historical background, "Internet +" combined with drug prevention education will break the restriction of time and space and provide more and more efficient communication channels. We can also set up a channel for volunteer activity registration and development to stimulate the users' internal motivation to participate in anti-drug activities.

3.3. Realize the precision of education and improve the teaching quality

"Internet + drug prevention education" can turn the "rough" traditional drug prevention education to "precision". Faced with teenagers of different ages, their physiological and psychological characteristics, knowledge level and cognitive ability are also different. Therefore, "Internet + drug prevention education" can focus on their stage characteristics in a different and targeted way. Drug-control education should build a horizontal system. 3.4. Pay attention to the timeliness of the content and reduce the waste of resources

According to the National Drug Laboratory, the rapid development and spread of new psychoactive substances is a prominent problem facing the world, while the new psychoactive substances are still blank in the traditional drug prevention education. Teenagers are in the age stage of continuous improvement of cognitive level, and strong curiosity is a prominent feature.
