2.4. Single form of anti-drug propaganda

Anti-drug propaganda also adopts the form of "old" propaganda, such as basic social members known as "marijuana, opium, heroin, methamphetamine and other" conventional drug varieties are still popular with the public, which not only reduces the efficiency of anti-drug propaganda work, but also leads to the understanding of drugs and also stays on the common drugs. However, the reality is that "LSD, rainbow smoke, small branches and other" new drugs instead of "marijuana, opium and other" traditional drugs quietly stepped on the stage of history, and become the main drug of young drug users[4]. 5.1.2. Enter the network

The Internet has the advantages of easy to find and convenient sharing, and can give full play to the optimization and integration of the Internet in the allocation of social resources. The unlimited potential of the Internet, which can boost the development of China's education causes a higher level. Therefore, innovating the traditional education mode and combining Internet technology with the drug prevention education, and make up for the deficiency of the traditional drug prevention education[8]. Through the joint street community staff, drug rehabilitation center, public security bureau and other social departments, into the district public business places to carry out anti-drug inspection and publicity activities. By entering public entertainment places that are easy to breed drug addicts, carrying out anti-drug publicity and education and supervision, enhancing people's awareness of identifying, preventing and resisting drugs, actively encouraging the people to report clues of drug addicts, and do a good job in the collection of drug addicts in society.

5.1.6. Enter the industry

Establish an anti-virus system for organs and enterprises, and strengthen the awareness of organs and enterprises. Through to various government organizations, enterprises and institutions to carry out anti-drug propaganda, adjust measures to local conditions to organize for civil servants, institution personnel and enterprise employees effective form of drug knowledge competition, to ensure the anti-drug publicity and education activities and prevention work, at the same time the unit of anti-drug work assessment into the anti-drug people's war, public security comprehensive treatment and create safe assessment category, and form a long-term mechanism[11].
